Privacy Notice

ESO collects and maintains personal data to be included in the Directory of Astronomy Librarians and Libraries. Personal data collected for the directory is only used for the purpose of publishing the directory. ESO will not collect or use personal data for commercial purposes.

ESO, through the implementation of its mission that is decided by its Member States, is committed to the protection of all personal data within its possession or as provided. As ESO's privileges and immunities include the inviolability of its premises and archives, personal data protection at/by ESO, including the rights of data subjects, follows some specific rules that are explained below.

Submitting data to the Directory of Astronomy Librarians and Libraries is voluntary. By doing so, data subjects grant ESO the permission to use their data for the intended purpose as described here and on the website.

ESO occasionally provides the email addresses to subject conference organisers for mailings of conference announcements.
